Dear Mr. Horner:

I refer to our letter dated October 5, 2015, regarding the release of certain Department of State material under the Freedom of Information Act (the "FOIA"), 5 U.S.C. § 552.

The search of the records of the Bureau of Diplomatic Security has been completed and resulted in the retrieval of six documents responsive to your request. After reviewing these documents, we have determined that one may be released in full, three may be released in part, and two must be withheld in full. For the two documents withheld in full, one was withheld under FOIA Exemptions 1, 5, 6, and 7(C), 5 U.S.C. §§ 552(b)(1), (b)(5), (b)(6), and (b)(7)(C); and one was withheld under FOIA Exemptions 1 and 5, 5 U.S.C. §§ 552(b)(1) and (b)(5).

The search of the records of the Office of the Executive Secretariat has been completed and resulted in the retrieval of three documents responsive to your request. After reviewing these documents, we have determined that all three may be released in full.

An enclosure explains the FOIA exemptions and other grounds for withholding material. Where we have made excisions, the applicable exemptions are marked on each document. All non-exempt material that is reasonably segregable from the exempt material has been released. All released material is enclosed.

We will keep you informed as your case progresses. 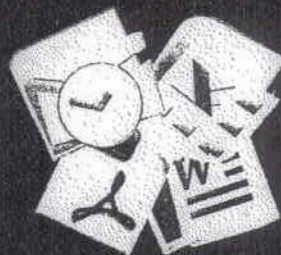
