Methodology

- Online survey among 1,200 registered voters nationwide conducted by CRC Research September 23 – 27, 2021. Respondents were selected randomly from opt-in panel participants.
- Sampling controls were used to ensure that a proportional and representative number of respondents were interviewed from such demographic groups as age, gender, race, and geographic region.
 - Gender breakdown: 48% men 52% women
- ±2.83% overall margin of error at the 95% confidence interval for overall survey. M.O.E.s for subgroups are larger.
